When you see 'Pedal Revolution' on the left, look for the chevron blocks at the entrance of a driveway into Estuary Farm on the right.  Take this turning and follow the road down towards the site which is approximately ¾ mile from the main road.  From the town: Leave Kings Lynn by the A1078. After you pass the main fire station on the left, continue for about 100m, look for chevron blocks on the left and a Greenworld sign.  Take this turning and follow the road down towards the site which is approximately ¾ mile from the main road.

8	Re-enter the weighbridge and weigh out taking the weighbridge ticket as your record of the tip.					
9	9 Please note no smoking or eating on site at any time.					
10	A First Aid kit is available in the Weighbridge room.					
11	11 Report any accidents or incidents before leaving site.
